

AQUIS EXCHANGE FEE SCHEDULE MARKET DATA (effective 1st January 2026)

This schedule constitutes a part of the Aquis Market Data Terms and Conditions, Aquis Exchange Data Distribution Licence, Direct Data Licence and/or Non-Display Data Licence (together, the "**Data Licences**"). Capitalised terms within this schedule hold the definitions provided in the Aquis Market Data Terms and Conditions.

This schedule applies to the Market Data provided by Aquis Markets, which includes Aquis Exchange UK ("AQXE"), Aquis Exchange Europe ("AQEU"), and Aquis Stock Exchange ("AQSE").

All fees stated in this schedule are applicable monthly unless otherwise stated. All fees related to the Data Licences are billed in advance, denominated in GBP (£) and are exclusive of VAT. Terminal fees are billed in arrears.

The following fees apply to Market Data from all trading services from AQXE, AQEU and AQSE. Entities that intend to use or distribute delayed data are responsible for delaying the data by at least 15 minutes.

- Fees per User are applicable to professional users only. Unit of count for billing purposes is based on the number of terminals/devices. Aquis ensures through a bi-annual reconciliation process that individual users are charged only once when they access display data via multiple re-distributors.
- ² Aguis segments encompass AQXE, AQEU and AQSE.
- ³ Direct receipt and Non-Display Data include Level 2 pre-trade information.
- Member Firms include participants paying either a trading subscription fee or designated liquidity providers on AQXE and AQEU. Any fee exemptions only apply for the market segment of membership.
- Members' Non-Display Data fees will be based on the subscription tier they have been in for the majority of the previous twelve calendar months.
- In accordance with Regulation (EU) No 600/2014 of the European Parliament and of the Council of 15 May 2014 on markets in financial instruments and amending Regulation (EU) No 648/2012 Text with EEA relevance and the corresponding UK equivalent of Regulation (EU) No 600/2014 (MiFIR)), 15-minute delayed market data from Aquis is available free of charge.
- If a Member is paying the Volume-only MaC Data fee and begins trading on MaC, Aquis will only bill the Member the difference between that fee and their MaC trading fees each calendar month. If the Member accrues at least the equivalent in MaC trading fees during the month, the Volume-only MaC Data fee will be fully offset. For Customers who are not Members but direct flow to MaC (for example via Direct Electronic Access or similar arrangements) through a Member, the Volume-only MaC Data fee will be waived once such directed flow reaches an average daily value of at least £25 million each calendar month.
