Subject: [Action Required - All Customers] Lit Functionality, Market Data & Drop Copy

Upgrades

#### Overview

Aquis Exchange will be introducing enhancements to our Lit functionality, a new Market Data flag, and a new field on Drop Copy.

These changes, subject to regulatory non-objection, will apply to both Aquis UK (AQXE) and Aquis EU (AQEU) platforms, from start of day on the following dates:

Test Environment: Monday 25th September 2023

Production Environment: Monday 30th October 2023

Members, software providers and market data recipients are advised to review this notice and the attached draft FIX/ATP, Market data, and Drop Copy specifications (subject to change) to determine if or how their systems will be impacted, whether or not you intend to use the new functionality.

#### What's changing?

Aquis is changing the non-client facilitating proprietary trading rule that currently applies on the Lit books.

Following the change, non-client facilitating proprietary flow will be able to trade aggressively.

Liquidity Providers will have the option to restrict their Lit passive liquidity to trade against client facilitating aggressive flow only, or to make it open to any flow.

The following enhancements will be made to the lit trading service on Aquis UK and Aquis EU (MICs: AQXE and AQEU respectively):

- 1. new 'Restricted order' types on FIX and ATP.
- 2. new 'Restricted' Sweep order types on FIX and ATP.
- 3. new field 'Flags' on market data.
- 4. an unrelated update will be made to the drop copy specifications: Currency (tag15) to be returned if using RIC.



# Points 1, 2 & 3: Restricted orders, Restricted Sweep orders, and new market data field.

#### Summary of Changes

Liquidity Providers will have the option to send 'Restricted' passive orders to Aquis' lit books AQXE and AQEU. Only client facilitating contra liquidity will be able to trade against these orders.

Non client facilitating proprietary aggressive flow cannot interact with 'Restricted' orders. To trade aggressively, this type of flow will need to use the new 'Restricted' order types via their dedicated non-client facilitating sessions.

Liquidity Providers will also be able to send 'Restricted' sweep orders targeting Aquis' lit books. These orders will sweep the AMP dark book before resting on the lit book as Restricted passive orders.

#### Impacts for FIX users:

New order attributes have been introduced in AquisOrderAttribute.

- When OrdType=2 (Limit), new values 5 and 6 are required in AquisOrderAttribute to use the new 'Restricted' order functionality. The existing Post-Only and POCR AquisOrderAttribute values (1 and 2), when used for passive orders, will be 'Unrestricted'.
  - TimeInForce=0, Day should be used by Liquidity providers to send passive orders to rest on the book.
  - o TimeInForce=3, or TimeInForce=4, IOC or FOK should be used by non-client facilitating trading sessions to remove liquidity from the book.
- When OrdType=P (Pegged, for AMP and Dark-to-Lit Sweep), new values 5 and 6 are required to use the new 'Restricted' sweep order functionality. The existing 'Route to Lit Post-Only' and 'Route to Lit POCR' AquisOrderAttribute values (1 and 2) will be 'Unrestricted'.
  - TimeInForce=3, IOC should be used by non-client facilitating trading sessions to remove liquidity from the book.

### Impacts for ATP users:

New order type values introduced in orderType.

- New values 10 and 11 are required to use the new 'Restricted order' functionality.
  - timeInForce=1, Day order should be used by Liquidity providers to send passive orders to rest on the book.
  - timeInForce=2, or timeInForce=3, Fill or Kill (FOK) or Immediate or Cancel (IOC) should be used by non-client facilitating trading sessions to remove liquidity from the book.

The existing POCR and Post-Only orderTypes (8 and 9), when used for passive orders, will be 'Unrestricted'.

Tag 15 is currently only returned when tag 22 (IDSource) = 4 (ISIN). It will now also be returned on orders and trades when tag 22 = 5 (RIC).
