

TICK SIZES

Aquis Exchange uses the ESMA tick size regime introduced with MiFID II.

The following tick size liquidity bands, which correspond with the values prescribed by ESMA, are included in our tick file:

- "ADNT_0_10" (0 ≤ Average daily number of transactions < 10)
- "ADNT_10_80" (10 ≤ Average daily number of transactions < 80)
- "ADNT_80_600" (80 ≤ Average daily number of transactions < 600)
- "ADNT_600_2000" (600 ≤ Average daily number of transactions < 2000)
- "ADNT_2000_9000" (2000 ≤ Average daily number of transactions < 9000)
- "ADNT_9000+" (9000 ≤ Average daily number of transactions)

The applicable liquidity band for each security is shown in the Aquis security list, using the 'tick name' column.

The liquidity band that applies to each security may change on an annual basis, when the latest Average Daily Number of Transactions (ADNT) values will be published.
